Results of the State Elections Tuesday November 8, 2022

The polls were declared open at 7:00 AM by David O. Whitbeck, Constable.

Of the town's one hundred thirty-nine registered voters one hundred six cast their ballots. There were no provisional or challenged ballots cast. There were no ESS ballots cast. There were no marked ballots that were not cast. There were 18 Early Voter Ballots sent out and 11 returned. There were 200 Official Ballots received, 95 were cast and 105 unspoiled at the close of polls. The ballot box counter started at zero and ended at one hundred and six. There were one hundred six names checked off on the check-in list and one hundred six checked off on the check-out list.
