Doings of the State Primary September 6, 2012

The polls were declared open at 7:00 am by David O. Whitbeck, Constable. Of the Town's one-hundred twenty-two registered voters 38 cast their ballots. Two Republican ballots were cast of the 50 delivered. Thirty-three Democratic ballots were cast of the 100 delivered. Two Green-Rainbow ballots were cast of the 50 delivered. One of the 10 Republican absentee ballots was cast. None of the 25 Green-Rainbow and none of the 10 Democratic absentee ballots were sent out or cast. There were no ballots cast on the ESS machine. There were 50 ESS Democrat, Republican, and Green-Rainbow ballots delivered and unspoiled. Poll workers were: David O. Whitbeck, Constable; Gail Garrett, Town Clerk; Victorine Torrico; Nancy Wright; Elizabeth Garrett; Brian Tobin; Judy Whitbeck, Phil Garrett, Cope Garrett; Karen Smith; Carolyn Romano; Nancy Bott; Anita Garrett; Eleanor Wilkinson; Wally Crowell and Mary King Austin. There were no provisional or challenged ballots cast. There were no marked ballots that were not cast. The ballot box counter started at zero and ended at 38. There were 38 names checked off on the check in list and 38 checked off on the check out list. Fourteen unenrolled voters cast Democratic ballots. Two unenrolled voters cast Republican ballots and one unenrolled voter cast a Green-Rainbow ballot.
